After research at Harvard University and MIT, Dr Vladan Ivanović earned his PhD in political economy from University of Hohenheim – Stuttgart, Germany. He earned his first PhD from University of Kragujevac, where he is full professor of economics. Dr Ivanović is fellow at the Foundation of Karl University in Prague and Centre for Economic Research of the Czech Academy of Science.

With vast experience in innovation economics, institutional economics, applied economic analysis, and econometrics, he consults international and national clients including the World Bank, USAID, European Union, Olaf Palme, WWGlobal, Western Balkan Fund, ICT HUB, Konrad Adenauer Foundation, Foundation Center for Democracy, Open Society Fund. He created the first instrument for monitoring the digital labour market in Southeast Europe ("Gigmeter"). Consultant to strategic consultancy IPG Group Zurich, Switzerland. He is one of the co-founders of the Serbian Venture Capital Fund Omorika.
